Registration as conveyor

With regard to your application of 2023-09-04 to be registered in the Danish National Waste Register, the Danish Energy Agency hereby informs you that your application has been accepted and Rhenus RETrans GmbH & Co. KG, VAT-no. 126635704 has been registered as a waste conveyor.

Your registration certificate is enclosed. The registration certificate is in both Danish and English.

The Danish Energy Agency reminds you, that any changes to the registered data must be updated within 14 days. You must register your changes on [Affaldsregister](#) (Waste Register). See also § 14 of the Danish Statutory Order on the National Waste Register and Authorization as collector.

When your company is transporting waste in Denmark, the Danish Energy Agency advises the driver to carry a copy of the registration, although it is not legally required.

The Danish Energy Agency must inform you, that it is the company actually carrying out the transportation of waste which is legally required to be registered in the Danish National Waste Register. Therefore all conveyors of waste, Danish as well as foreign, with their own conveyor permit are required to register in the Danish National Waste Register. You can read more about this on the [Danish Energy Agency's website](#).

Notice that when transporting waste from one country to another, according to regulation 1013/2006 you must carry the Movement document (Annex 1B) and copies of the competent authorities' consents of the notification document (Annex 1A). If the waste is classified as green listed waste you must carry the Annex VII (instead of Annex 1A and Annex 1B). You have to pay an annual fee to remain on the register. The fee is adjusted annually and will be published on the [Danish Energy Agency's website](#). You do not have to pay a fee for changing details on your registration.
