

GENERAL INFORMATION

The Management of Rhenus Logistics B.V. aims to reduce risks to a minimum and to prevent accidents, involving employees of third parties who may be visiting or working on the premises, either professionally or with permission.

On the terminal heavy duty equipment in combination with high frequency traffic flows require specific guidance and safety rules for third party visitors, not familiar with the specific dangers and risks related to visiting the terminal. Please follow below instructions. Rhenus Logistics B.V. Deep Sea Terminal is an ISPS certified terminal. Security measures on the terminal could be escalated should national authorities require Rhenus Logistics to do so.

1. REPORT TO THE SECURITY GATE

Every visitor to Rhenus Logistics' terminal should report to the gatekeeper who will refer them to the responsible Rhenus Logistics employee. Every visitor is required to register himself at the security gate. Visitors should identify themselves to the gatekeeper by passport, driver's license or identity card. Upon departure visitors should report and sign out at the security gate.

2. LIABILITY

Every visitor to Rhenus Logistics' terminal, accompanied by (commercial) vehicle or not, does so at their own risk. Rhenus Logistics and its employees cannot be held liable for any damage.

3. SAFETY MEASURES AT THE TERMINAL

Upon entering the terminal visitors are required to wear high visibility vest, safety shoes and safety helmet at all times. At the security gate this personal protective equipment is available for sale. Instructions from Rhenus Logistics personnel must be followed at all times.

4. SAFETY ONBOARD VESSELS

Visitors and passengers must embark through the recognized passenger entrance unless otherwise indicated by the ships officer. Always take the shortest and safest route to the entrance of the vessel (gangway). On board the vessel visitors and passengers must report to the ships officer and will be briefed about safety instructions and applicable rules on board the vessel.

5. ROAD SAFETY AT TERMINAL

On the terminal the "Wegenverkeerswet" (Road Traffic Code) applies.

Furthermore:

- Maximum speed allowed on the terminal is 15 km per hour
- Traffic signs, lane directions and symbols must be obeyed at all times
- Vehicles must park in designated areas. In all other areas parking is allowed only with permission of terminal management

6. ALCOHOL AND DRUGS

It is prohibited being in possession of and being under the influence of alcoholic drinks and/ or other stimulants on Rhenus Logistics' premises. Smoking is prohibited on the terminal except in designated smoking areas.

7. COMPLIANCE

In case of non-compliance to these instructions, particularly safety, environment, hygiene and/ or traffic offences, Rhenus Logistics reserves the right to remove the involved person or people and refuse further access to the terminal and/ or offices. Rhenus may bring activities to a halt without accepting liability in any way for possible (financial) consequences.
